Important Instructions for Selected Aspirants – JATF Admission 2025

1. Final Year Mark Sheet Submission

Aspirants who have not submitted their final year mark sheet must do so by **July 30, 2025**. Their admission will remain provisional until the mark sheet is submitted. In case the student fails to provide the necessary documentation without a valid reason, their admission will be withdrawn. Management's decision in such cases will be final.

2. Minority Certificate Submission

Aspirants who have not submitted their government-declared Minority Certificate must submit it at the time of admission. This is mandatory for completing the admission process.

3. Joining at Respective Centres

The reporting/joining dates for all selected aspirants are on June 25, 2025. All aspirants must report to their allocated centre within this time frame. Failure to report within these dates will result in cancellation of admission, and the seat will be allotted to a waitlisted candidate. The Admission Letter, along with the Rules & Regulations, will be emailed to each candidate within two days.

4. Seat Allotment & Centre Preference Policy

Seats are allotted based on the candidate's centre preference and overall merit rank.

- If a candidate does not get their first choice, they will be placed on the waiting list for that centre.
- If the second choice is allotted, admission will be granted accordingly, and the candidate will still remain on the waiting list for their first choice (if applicable).
- The same applies to the third choice, and so on.
- Aspirants who are in the waiting list will get admission in case aspirants fail to join the centre within the time frame.
- Aspirants who do not join the allotted centre will also not be eligible for an upgrade to their preferred centre choice.

5. Waiting List Publication

The waiting list will be published within 7 days after the initial admission confirmation phase.

6. Orientation Program – June 29, 2025 (Delhi)

An Orientation Program for selected aspirants will be conducted on June 29, 2025, in Delhi.

- Delhi, Jaipur, and Indore centre aspirants: Physical attendance is mandatory along with parents/guardians.
- Pune and Bangalore centre aspirants: Orientation will be conducted online from their respective centres.

You will receive complete details of the Orientation Program in your admission letter.

7. Download & Print Handbook

All selected aspirants must download and print the Handbook shared on their registered email ID. This printed copy must be submitted at the time of admission.

8. Important Note on Admission Continuity

Admission or selection does not guarantee continued stay at the centre. Continuation will depend on:

- Fulfilment of all admission-related terms and conditions
- Strict discipline and adherence to the centre's rules and regulations
